## Career Opportunities for Tax Professionals

As changing tax laws become more complex, individuals and corporations must employ trained specialists to assist them with their tax planning and preparation. According to the Department of Labor, job growth for tax professionals is projected to increase at a faster rate than the average for other occupations. Thus, exciting career opportunities will exist for qualified financial professionals who have a solid background in taxation.

### The Taxation Profession

Demand for qualified tax professionals is expanding!
Continual changes to the tax code and regulations, in addition to a new focus on ethical tax preparation practices, are fueling the demand for qualified tax professionals. Tax professionals can choose from a number of career paths that present exciting opportunities, including:

Most tax professionals need a bachelor's degree in taxation, accounting, economics, or business administration, and many have a master's degree or JD in taxation or industry certification such as the CPA or Enrolled Agent (EA) designations. Continuing education is also vital to tax professionals who want to advance their careers, given the growing complexity of tax laws and regulations.

## Qualities and Skills to Succeed

To be successful, tax professionals should:

- Be highly knowledgeable of the tax code and regulatory compliance procedures.
- Have excellent interpersonal skills and an aptitude for working with numbers.
- · Have high standards of integrity.
- Have an aptitude for mathematics and be able to analyze, compare, and interpret facts and figures quickly.
- Be good at working with people, business systems, and computers.

 Be creative thinkers and problemsolvers, applying their analytical skills to business.

Relevant work experience is also critical for those who want to move their careers forward. Those who broaden their technical skills and exhibit their competency by attaining professional certification will also have the best chances for career advancement.
